


The Government of Santa Catarina and Santur are pleased to make available to all tourists this booklet that brings together the main information for a safe summer season for everyone. In this booklet, you will also have access to general guidelines on prevention and protection against Covid-19, telephone numbers and useful links.

General measures for prevention and protection against Covid-19:

- 1) Get vaccinated against Covid-19. Pay attention to the number of doses and the prescribed interval in order to have complete immunisation;
- 2) Pay attention to the booster dose. If five (05) months have passed since the last dose of the primary vaccination scheme, it is time to receive the booster dose;
- **3**) Encourage the vaccination of your social circle (relatives and friends) as well as work colleagues;
- 4) It is preferable to go to places and participate in social events that have open-air, well-ventilated and uncrowded spaces.
- 5) Give preference to open venues and outdoor, uncrowded events;
- 6) Have an extra clean mask in case it needs to be changed (time of use, humidity or dirt)

- **7)** Crowds should always be avoided and, if this is not possible, a safe distance (of at least one metre) from other people or groups of people should be maintained. Do not remove your mask;
- 8) Wash your hands frequently, using soap and water or 70% alcohol gel
- **9**) After touching objects that are being shared with others (e.g. utensils for serving food, jugs and bottles), wash your hands with soap and water or use alcohol gel 70%.



BEACH & OPEN AND CLOSED SPACES & EVENTS & TOURIST ATTRACTIONS



Ordinance No. 1398 of the State Health Department (SES), in force in Santa Catarina, determines the parameters for holding events and also the conduct and posture in closed venues

- The municipality is responsible for authorising and supervising establishments promoting large-scale events or events with more than 500 participants, in closed or open venues, with or without public access control;

ORDINANCE SES No. 1398

Events

• You must present proof of complete vaccination (two doses or a single dose of Covid-19 vaccine) or present the RT-PCR examination report from the last 72 (seventy-two) hours or a swab test for SARS-Cov-2 antigen carried out in the last 48 (forty-eight) hours with a "negative, non-reactive or non-detected" result;

- •For 12- to 17-year-olds: proof of vaccination with a record of at least one dose of Covid-19 vaccine or a report of a RT-qPCR test performed within the last 72 hours or a swab test for SARS-Cov-2 antigen testing performed within the last 48 hours with a "negative, non-reactive or non-detected" result;
- For people under 12 years of age, proof of vaccination or testing will not be required, provided they are accompanied by parents or guardians and stay in areas without crowds, keeping their distance and complying with the rules on wearing masks, except in cases provided for by law;
- To prove the complete vaccination scheme, the customer/tourist must present proof of vaccination through the "Conecte SUS" application or through a certificate, booklet or vaccination card printed on letterhead issued by the Municipal Health Secretariat or other national or foreign government institutions that contains a record of two doses of vaccines from Pfizer, Sinovac/Butantan or Astrazeneca/Fiocruz laboratories or a single dose from the Janssen laboratory.
- To prove the negative result of the RT-qPCR test or the SARS-Cov-2 antigen test, the customer must present the printed report from accredited establishments, which must be retained by the establishment for up to 30 days;

 The falsification of the documents established in this article for access to events with protocol represents a health infraction and will imply the imposition of penalties provided by law for the client;

Foreigners

People immunized in other countries may present the international certificate of vaccination with the record of the application of the Covid-19 vaccine to prove the complete vaccination scheme;

Beaches and marinas in Santa Catarina with Blue Flag certification



Obtaining the Blue Flag guarantees visitors more information about the sites, water quality and environmental education actions. The programme was created by the FEE (Foundation for Environmental Education), an international institution with several members representing their respective countries. In Brazil, the national operator of the programme is the Instituto Ambientes em Rede (IAR).

Santa Catarina is the "bluest" State in Brazil.


